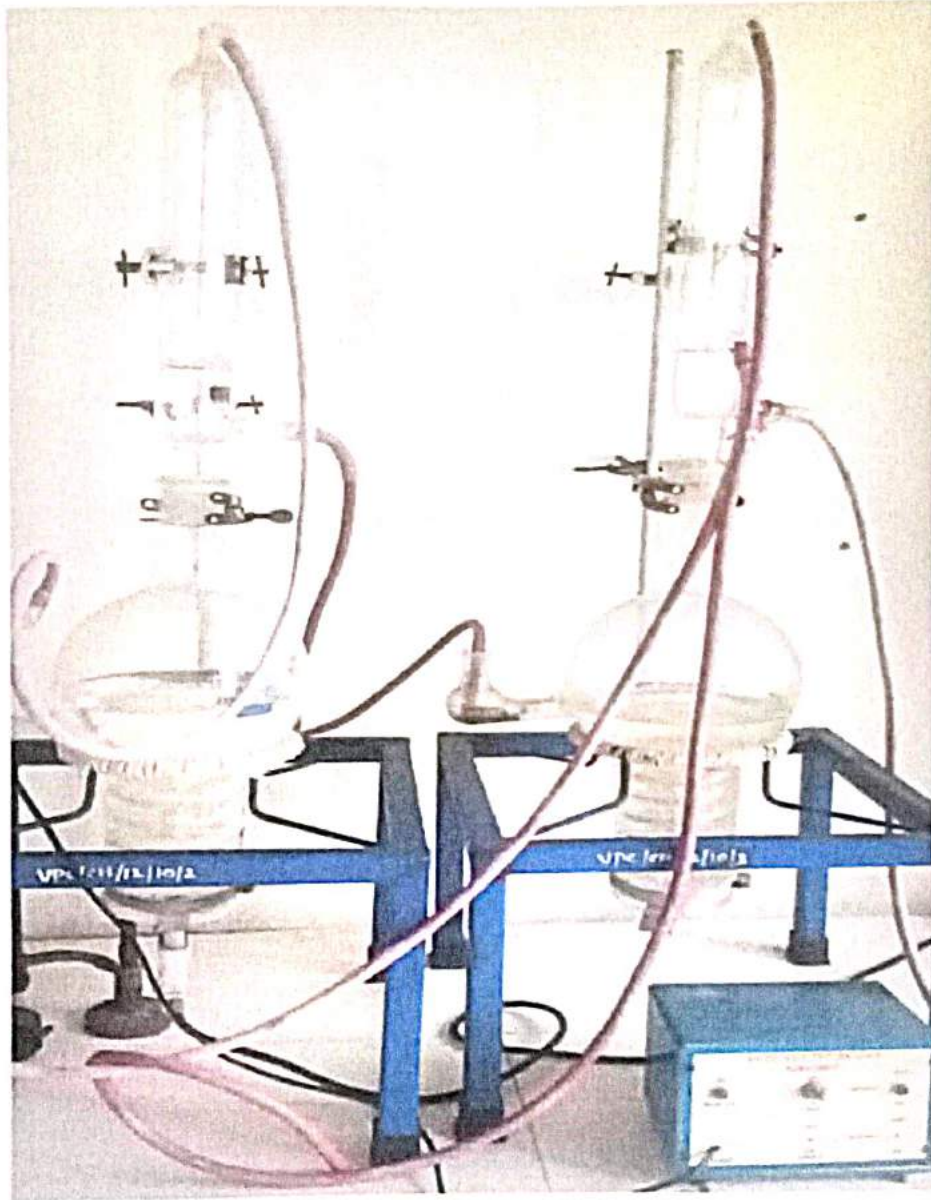
POLE CLIMBING APPARATUS

OBJECTIVES OF THE RESEARCH POLICY

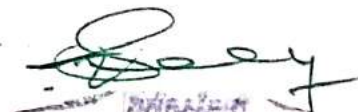
1. To provide policy guidelines and direction for the growth and Development of research activities.
2. To advice on trust areas and disciplines for introducing research programs and related activities for future development in research.
3. To suggest measures for improving existing infrastructure facilities both for academic and sponsored research and enhancing research ambiance.
4. To recommend projects and suitable for availing concession if any from state and central govts.
5. To promote research by extending financial assistance to the faculty members of the college.
6. To promote collaborative research activities with National & International Universities/Research Institution/Industries

The College designed a policy that promotes the growth and development of research activity amongst the faculty and students with the objective to achieve the mission of 'idea to value'.

The salient features of the 'Research Promotion Policy' are:

- (i). Provide Rs. 4.00 lakhs per annum in the college budget towards financial assistance to the faculty engaged in research,
- (ii). Include 'projects by research' in the curriculum of Postgraduate programs
- (iii). Encourage the faculty to enrol for PhD program through financial assistance and granting leave
- (iv). Encourage the faculty to undertake Major and Minor Research Projects with financial assistance from the national funding agencies / college,
- (v). Improving the existing infrastructure facilities both for academic and sponsored research and for enhancing research ambiance,
- (vi). Pursue collaborative research with Universities / Research Institution / Industries

(vii). Create awareness among the faculty on IPR, Patents, Start-ups, Incubation centers through expert lectures

(viii). Select every year one faculty member for 'Best Researcher Award' based on research output (like research project(s), a minimum of two publication in UGC-CARE journals as first author, two paper presentation in symposia / seminar / conference, and guiding a minimum of 5 student projects), and provide one additional increment as an incentive.

(ix). Constitute a 'Research Advisory Committee' with external experts for advising the college / faculty in contemporary research and thrust areas, and to provide guidance in all matters relating to academic research in the college.

The 'Research Policy' of the College has been approved by the Governing Body in its meeting held on 20-02-2021.

Policy for Financial Support to Teachers for Attending Conferences/Seminars/Workshops
and Towards Membership Fee of Professional Bodies

GUIDELINES FOR FINANCIAL ASSISTANCE

The Guidelines for extending Financial Assistance to the Faculty members of the college who intend to attend Conferences/Workshops/Seminars and towards Membership Fee of Professional Bodies.

- a) Attending Professional Development Programs/ Seminars/ Workshops: Registration fee to attend a person at professional development programs/seminars/workshops subject to a maximum of Rs. 2,000/-.
 - b) Library/Institutional Membership: Membership Fee in Libraries and Research Institutions or Bodies, provided that such membership helps in collection of data / reference work etc. and subject to a maximum of Rs. 2000/-
 - c) Membership in Academic/Professional Bodies: Grant Financial Assistance to faculty for membership to professional bodies. The assistance of the membership fee is upto a maximum of Rs 500/- each year.
- ✦ The Total Fund of Rs. 1,00,000/- (one lakh) for the academic year and the applications received may be processed once in a year.
 - ✦ The Faculty who has been appointed by a duly constituted selection committee is only eligible for the above Financial Assistance.
 - ✦ A faculty member may apply for Financial Assistance to one or more of the above items, but the total assistance to a single faculty shall not exceed Rs. 3,000/-.

FINANCIAL ASSISTANCE TO PROMOTE RESEARCH CULTURE IN THE COLLEGE

GUIDELINES FOR FINANCIAL ASSISTANCE TO PROMOTE RESEARCH CULTURE IN THE COLLEGE

By virtue of the powers vested in clause 3(c) of the Statute concerned, the 'Research Advisory Committee (RAC)' formulates the following guidelines and criteria for granting financial support to the faculty and students who carry out academic research and projects in the College:

1.0 Doctoral Research: Teachers, who have registered for Ph D program of any university, either state or private but recognized by the UGC / AIU for the purpose, are eligible to apply for the following grants once in the duration of the program:

- (a) Registration fee (not the course fee) subject to a maximum of Rs. 2000/- (Two Thousand Rupees Only),
- (b) Cost of consumables, minor equipment, data collection, spectra etc., subject to a maximum of Rs 10,000/- (Ten Thousand Rupees Only),
- (c) Expenditure towards publishing scientific papers / articles in refereed journals, reviews, manuals, books etc, subject to a maximum of Rs. 2000/- (Two Thousand Rupees Only) Per Paper / Review / Article / Manual, and Rs. 5,000/- (Five Thousand Rupees) for a book. (d) Preparation of thesis for the award of PhD degree, subject to a maximum of Rs. 10,000/-.

The eligibility criteria for the above grant is that he / she is a permanent teacher appointed by a duly constituted committee, and should have completed 2 years of probationary service in a degree college.

2.0 Research Projects: Teachers may apply for financial support up to a maximum Rs. 20,000/- (twenty thousand rupees only) to a Research Project of at least one /two years duration, and which was earlier submitted to an external funding agency but not selected. The grant is meant for purchase of consumables / minor equipment / data collection / spectra etc., but not for remuneration to the investigators / staff. This grant is subject to the following rules:

- (a) A maximum of 12 research projects per year will be selected for financial support by the college, and the Governing Body is the competent authority to increase this number in deserving cases and with proper justification,
- (b) If more than one teacher is involved in the research project, the proposal shall be submitted by the Principal Investigator,
- (c) Inter-departmental research projects are also eligible for the grant, and shall be encouraged,
- (d) The proposal should be submitted in the prescribed pro-forma, and they will be accepted twice in a year – first week of June / December,
- (e) The financial grant shall be based on the recommendation of an expert committee constituted by the college for the purpose,
- (f) The grant will be disbursed in two equal installments - the first installment shall be disbursed within 15 days from the date of awarding the grant, and the second after settling the accounts in full for the amount drawn thus far,
- (g) The Principal Investigator should submit reports on the progress in the research project for every 3 months, and failure to submit the reports consecutively for two quarters may entail revoking the financial support,
- (h) At least, one paper should be communicated for publication in UGCCARE listed journals, failing which the investigator(s) will become ineligible for any research grant by the college in future,

The eligibility criteria for the above grant is that the Principal Investigator is a permanent teacher of the college appointed by a duly constituted committee, and should have completed 2 years of probationary service in a degree college.

3.0 Patenting: Teachers who obtained a National / International Patent for any product of the research work carried out in the college will be awarded Rs 10.000/- (ten thousand rupees only) per patent.

4.0 Paper Presentations at Seminar / Symposia: Teachers who have submitted a research paper / article to a national / international seminar / symposium / conference, and presenting in person, are eligible for grant of financial assistance to a maximum of Rs. 2000/- (two thousand

rupees only) towards the Registration Fee. Papers submitted in absentia are not eligible for any financial assistance.

5.0 Student Projects:The post-graduate students who are in the final semester and doing a research project as part of their curriculum are eligible for financial support to a maximum of Rs. 1000/- (one thousand rupees) per project towards the cost of chemicals / materials / computer work / xerox etc. The Head of the Department concerned shall claim this amount and spend it for the purpose.

The faculty member who guided the student officially in the research project and published the work in UGC-CARE listed journal will be rewarded with Rs.500/- (five hundred rupees only) per paper.

6.0 General Rules:

(a) The teachers should apply for the financial assistance in the proforma prescribed separately for each item and is available in the college website- www.vaagdevipharmacycollege.com

b) A teacher may apply for financial assistance to one or more of the listed items, but the total assistance to a single faculty shall not exceed Rs. 20,000/- (Twenty Thousand Rupees Only).

(c) The application received for Financial Assistance shall be processed twice in one year in the months of January and July.

(d) The teacher who availed the Financial Assistance for research must acknowledge the college while publishing the work to which the assistance is given.

(e) Any proven misuse of the grant will be viewed seriously and disciplinary action will be initiated against the teacher concerned.

(f) The Governing Body is the competent authority to decide on matters that are not covered by the rules listed above.
